

Regulations Beeldenstorm 2014

A. Introduction

Participants wishing to use the studio should make an appointment beforehand. For appointments and other issues, the studio can be reached by phone from Monday to Friday between 9:00am and 5:00pm.

Prior to a work period, your plans will be discussed with the studio facilitator. The BEELDENSTORM facilitators will draw up a support program on the basis of this plan of work and in consultation with the participant.

When using a new technique, the participants will be given instructions by the studio facilitator.

A starting fee will be charged for this service.

It is not allowed to carry out activities without prior instructions from the studio facilitator.

If possible, material costs, shifts, the fee for customized support, and the use of certain machines are discussed previously. Prices are set out in the price list. This price list is available at the studio facilitator. Every day the studio facilitator will record the use of materials and other costs on the daily statement. The artist would be well-advised to acquaint himself with the costs incurred and shifts worked by consulting with the present facilitator about this before leaving.

Material will be sold only if the sale is directly related to activities at BEELDENSTORM.

Make sure you are informed about the safety regulations prior to the start of your activities.

BEELDENSTORM reserves the right to document the working processes photographically for the purpose of archiving and publication.

B. Liability participant and BEELDENSTORM

Participants use the studio at their own risk and must have a third-party insurance.

If the participant is acting as an employer (in the case of, for example, an assistant), he must take out a business liability insurance policy. The participant should be able to produce copies of the insurance policies upon request.

Participants have their own responsibilities regarding safe working according to the instructions of the studio facilitator, wearing personal protective equipment (PPE), reporting dangerous situations, and order and neatness.

It is not permitted to perform work without prior instructions from the studio facilitator.

If improper use of tools, inventory or other equipment causes damage, this damage will be charged to the user in question.

BEELDENSTORM is not liable for:

- any damage, theft and loss of personal property including works of art of the participants;
- any damage caused by materials and equipment made available by BEELDENSTORM:
- any damage caused by any possible errors of BEELDENSTORM's supervisors.

C. Working at BEELDENSTORM

During the period in question the participant will have the disposal of the studio, the existing equipment and basic guidance.

You must handle materials and tools safely. For security reasons, and in order to be able to work undisturbed, interested parties are not admitted unless given explicit permission.

It is not allowed to enter the studio barefooted or wearing open footwear. When using the hoist track, safety footwear is compulsory. It is not allowed to use the hoist track without instructions from the studio facilitator. Only the studio facilitator is authorized to use the fork-lift/reach truck.

The use of alcohol and/or drugs in the studio is prohibited. For safety reasons it is not permitted to smoke in the office area nor in the studio.

Pets are not allowed, children only under strict conditions and after consultation. After use, tools must be put back again. Faulty equipment should never just be put back. Defects should be reported to the studio facilitator. Tools are never lent out.

After working hours the workplace must be left clean. Cleaning costs will be charged in case of negligence.

When working with machines that produce sparks and chips and/or cause a noise level above 85 dB(A) and when carrying out activities involving noxious fumes, it is compulsory to use the appropriate personal protective equipment (PPE). Users should be informed about this and should - in consultation - take care of the necessary protection themselves.

Directions from the studio facilitator who is in charge of observance of the safety rules must be followed by the participants. If these directions are not followed, he is authorized to deny the participant in question further use of the studio.

During certain activities in the studio you may come in contact with carcinogenic and/or reproductive-toxic substances (e.g. lead, plaster dust, and the like). The participant is obliged to strictly follow the guidelines and instructions from the studio facilitator relating to, among other things, the wearing of PPE.

It is not permitted to be in the warehouse or to open the chemicals cupboard without the consent of the studio facilitator. Without instructions from the studio facilitator and without the required PPE it is not allowed to use hazardous substances. Make sure you understand the contents of the Material Safety Data Sheets for the hazardous substances used. These can be found in the chemicals cupboards where the substances are stored. A Hazardous Substances Register* is in the possession of the studio facilitator and can be obtained from him.

Working with certain materials and tools will bring undue risk to the unborn child. If you are breastfeeding, this is also applicable for the newborn child. You are obliged to report this to the studio facilitator. The studio facilitator has the additional information and a list of activities that must not be carried out by pregnant or lactating women.
